

# MKI Training Program Consultant

We leverage collaborative professional and educational partnerships that increase access, encourage innovation, and build the capacity of the community development field.

#### **Program Description**

The Mel King Institute is committed to supporting and increasing the number of affordable housing project managers at CDCS and in the field. Our goal with the series is to provide consistent training and skill building for those new to the role, or those looking to advance into this rewarding work. The MKI Training Program Consultant will work with MKI's Professional Education team to design and plan the launch of the Building Foundations Training series this fall. Our training objectives include:

- **Providing a quality comprehensive training series** to prepare affordable housing project managers for the complex process of financing and developing housing in Massachusetts.
- Increasing the "pipeline" of skilled affordable housing project managers—CDCs as well as other nonprofit and for-profit developers continue to seek entry, mid and senior level project managers.
- Diversifying the backgrounds of project managers—Professionals in construction management, property
  management, and market rate developers in gateway cities, need access to the tools and the networks for
  affordable housing project management. This also means uplifting the knowledge of WMBEs positioning
  them as competitive players in the housing sector.
- Reflecting community demographics—Our neighborhoods and communities are diverse in race, cultural backgrounds, and income. Representation is important and builds community wealth. We look to increase the number of people of color in project management in affordable housing development.

The Building Foundations program will offer the following sessions:

**Detailed overview of the affordable housing development process in Massachusetts,** including identifying and securing sites, permitting, budgeting, financing (including terms, timelines, public and private funders), contractor bidding, and other predevelopment tasks, to prepare project managers for every step in the process. This includes case studies, key agency and organization mapping and essential applications and timelines.

**Community of Practice** webinars to enhance participants knowledge of the affordable housing system led by the Training Program Consultant and other experts in the field for 4-6 sessions such as design, how to read plans, construction management, how to work with OPMs, working with lenders/ investors, zoning, and legal issues.

#### The MKI Training Program Consultant Role:

The MKI Training Program Consultant reports to the MKI Director and collaborates with the Advisory Committee. This Consultant will define clear session goals and learning outcomes, coordinate the training instructors, and serve as a liaison to the MKI program partners. Please note there is a separate training and instruction budget for this program. The program Consultant may elect to offer to instruct some of the curriculum in addition to coordinating the program development and implementation.

#### **Curriculum Development**

- Assisting in the research, design, and planning of the new Building Foundations Project Manager Training Series,
- Developing clear goals and outcomes for the sessions,
- Assisting in the production of program and resource materials as needed,
- Creating content for marketing the sessions on website and related promotional materials,
- Recruiting and securing a diverse pool of instructors or session leaders including practitioners and affordable housing stakeholders for the fall launch, and
- Managing and maximizing the program budget.

#### **Program Management**

- Meeting regularly with the MKI Director
- Advisory committee communication with the committee and facilitation of 3-4 virtual meetings with the advisory committee for feedback and guidance

Please note the Mel King Institute will coordinate the logistics of the training, enroll students, and manage the administrative aspects of the program. This includes promoting the sessions, creating marketing materials, and conducting outreach to MACDC members and the MKI network.
